We hope this letter finds you well. As we enter the new year, we are excited to inform you about the upcoming Value-Based Contract Measurement Year which commenced January 1, 2024.

The PerformPlus<sup>™</sup> Total Cost of Care program is designed to enhance the quality of healthcare delivery and optimize patient outcomes and your opportunity to see residual results. One crucial aspect of this program involves closing HEDIS (Healthcare Effectiveness Data and Information Set) gaps in care. By addressing these gaps, we aim to elevate the overall standard of care and ensure that our enrollees receive the most comprehensive and effective treatment. Additionally, our focus extends to reducing the District's prioritized P4P measures:

- Low Acuity Non-Emergent (LANE): Percentage of avoidable, low-acuity non-emergent, emergency department visits.
- Potentially Preventable Hospitalizations: Percentage of inpatient admissions for specific ambulatory care conditions that may have been prevented through appropriate outpatient care.
- Plan All-Cause Readmissions (PCR): For patients ages 18-64, the number of acute inpatient stays during the measurement year that were followed by an acute readmission for any diagnosis within 30 calendar days and the predicted probability of an acute readmission.

Through these collaborative efforts, we seek to streamline patient care pathways, minimize unnecessary hospital admissions, and maximize the efficiency of healthcare resources.

Your active participation in these endeavors is vital to the success of our shared commitment to providing highquality, value-based care. We encourage you to engage with the AmeriHealth Caritas Value-Based Dashboard on NaviNet as well as the 3M platform. These tools are provided to support your efforts in closing HEDIS gaps and minimizing hospital utilization.
