Subject: DC Medicaid Fee Schedules

Dear Provider:

We are sending this notice regarding your contracted rates with AmeriHealth Caritas District of Columbia (DC). Historically, the Department of Health Care Finance (DHCF) has published the DC Medicaid Fee For Service (FFS) fee schedule to their web portal (<u>https://www.dc-</u>

<u>medicaid.com/dcwebportal/nonsecure/feeScheduleInquiry</u>). While Medicaid Managed Care Plans are not obligated to leverage the fee schedule published by FFS, AmeriHealth Caritas DC has opted to leverage the Standard DC Medicaid Fee Schedule (highlighted in yellow below) for many of our contracts to avoid a need to negotiate, and subsequently configure, rates for each individual service/code. This approach has streamlined our contracting efforts with many of our provider partners.

In addition to the Standard DC Medicaid Fee Schedule highlighted in yellow below, (identified as **Medical_Fee_Schedule.csv** on the downloadable version), DHCF also publishes multiple adjunct fee schedules to include specific adjuncts for **Dental**, **Anesthesia**, and **ASCs**. Recently, DHCF has added adjunct fee schedules specific to **Provider ID**, **Provider Type**, **and Provider Specialty**.

Unless otherwise stated, any reference to the "published DC Medicaid Fee Schedule" in existing contract language with AmeriHealth Caritas DC is configured based upon the "Standard Fee Schedule" as indicated on the interactive tool, or "Medical_Fee_Schedule.csv" if referencing the published downloadable files.

The new adjunct fee schedules do not apply to any contract ratified prior to their existence, or any current or future contract not explicitly agreeing to replace the Standard DC Medicaid Fee Schedule with an alternate source or reimbursement methodology.
