Subject: 2025 Provider Incentive CPT/CPT II Code Campaign for Eye Exam for Patients with Diabetes (EED)

Dear Provider:

AmeriHealth Caritas District of Columbia (DC) providers are invited to participate in an end-of-year provider incentive to optimize completion of the *Eye Exam for Patients with Diabetes (EED)* campaign. This initiative includes a quality incentive payment opportunity for enrollees who are identified as non-compliant as of September 2025 but identified to be compliant for measurement year (MY) 2025.

Compliance for EED is defined in the Measure Description below. Eligible enrollees for this incentive must be noted on the non-compliant list provided to your practice. AmeriHealth Caritas DC enrollees who are not listed on the non-compliant list are not eligible for the incentive payment.

Measure Description and Documentation Guidelines

Enrollees 18–75 years of age with diabetes (Type 1 and Type 2) who had a retinal eye exam during the measurement year (MY), an exam with a negative result in the year prior to the MY, or documentation of bilateral eye enucleation any time prior to 12/31 of the MY.

How do I participate?

Follow the steps below to participate in this campaign:

1. Email ACDC Quality Management to request a non-compliant list for you/your practice, vdavis3@amerihealthcaritasdc.com.
2. Review the non-compliant list.
3. Schedule appointments for enrollees to complete an eye exam as defined in the measure description above. These visits must be completed on or before December 31, 2025. Submit a claim for the eligible service(s) provided with the appropriate CPT/CPT-II codes following your normal claim submission procedures. For convenience, options for eye exam CPT/CPT II codes are provided below.

Retinal Eye Exams:

CPT: 92235, 92230, 92250, 99245, 99243, 99244, 99242, 99205, 99203, 99204, 99215, 99213, 99214, 92018, 92019, 92004, 92002, 92014, 92012, 92202, 92201, 92134

Retinal Imaging:

CPT: 92227, 92228

Low Risk for Retinopathy (none present in prior year):

CPT-CAT-II: 3072F

Eye Exam without Evidence of Retinopathy:

CPT-CAT-II: 2023F, 2025F, 2033F

Eye Exam with Evidence of Retinopathy (in the MY Only):

CPT-CAT-II: 2022F, 2024F, 2026F

Unilateral Eye Enucleation (with Bilateral Modifier or 2 Unilateral Enucleations More than 14 Days Apart):

CPT: 65091, 65093, 65101, 65103, 65105, 65110, 65112, 65114

When and how is the quality incentive paid?

Quality incentive payments are based on claims submission that provide evidence of completion of an eye exam for measurement year 2025 via CPT/CPT II codes submission. An incentive payment of \$50 will be paid for each enrollee on the non-compliant list who ends MY2025 as compliant. Compliance will be determined by reconciling the initial non-compliant list with the compliant list in **April 2026**, after the standard run-out period. Payments will be distributed in May 2026.
