Health Notice for District of Columbia Healthcare Providers
Coronavirus (COVID-19):
Updated Priorities for Testing Patients with Suspected COVID-19
Infection and Updated Prioritization of Contact Tracing by DC Health

Summary

Testing for Coronavirus 2019 (COVID-19) is now available through the DC Public Health Laboratory, commercial laboratories and some hospital-based clinical laboratories. While increasing testing capacity will allow clinicians to consider COVID-19 testing for a wider group of symptomatic patients, clinicians should also keep in mind that there is a national shortage of tests reagents and supplies.

- Clinicians should take into consideration the testing priorities listed in this health notice when evaluating a patient with respiratory symptoms and continue testing for other more common respiratory viruses.
- Clinicians should appropriately guide their patients on home quarantine while test results are pending
- Clinicians should be prepared to provide patients who test positive for COVID-19 with home-isolation guidelines and information for household and close contacts (**DC Health will now be limiting contact tracing to specific situations and high priority groups**)

DC Health has updated testing priorities in DC based upon the updated guidance from the Centers for Disease Control and Prevention released on March 24th (<https://www.cdc.gov/coronavirus/2019-nCoV/hcp/clinical-criteria.html>).

COVID-19 Testing Priorities in the District of Columbia

Priority 1

Ensures optimal care options for all hospitalized patients, lessen the risk of healthcare-associated infections, and maintain the integrity of the U.S. healthcare system. This includes:

- Hospitalized patients
- Healthcare facility workers with symptoms

Priority 2

Ensures those at highest risk of complication of infection are rapidly identified and appropriately triaged. This includes:

- Patients in long-term care facilities with symptoms
- Patients 65 years of age and older with symptoms
- Patients with underlying conditions with symptoms
- First responders with symptoms

Priority 3

As resources allow, test individuals in the surrounding community of rapidly increasing hospital cases to decrease community spread, and ensure health of essential workers. This includes:

- Critical infrastructure workers with symptoms

- Individuals who do not meet any of the above categories with symptoms
- Healthcare facility workers and first responders
- Individuals with mild symptoms in communities experiencing high numbers of COVID-19 hospitalizations

NON-PRIORITY

- Individuals without symptoms

Important Infection Control and Specimen Collection Reminders

Guidance for Patients with Pending or Positive COVID-19 Test Results

Due to the community spread of COVID-19 in DC, DC Health is now only conducting contact tracing investigations for specific situations (such as outbreaks, persons employed in occupations deemed to be at high risk of spreading COVID-19, etc.). Therefore, clinicians who order COVID-19 tests should be prepared to advise their patients on home-quarantine while test results are pending and home-isolation when a patients' tests are positive.
