Maternal mortality rates in the United States continue to rise compared to other industrialized countries, and tragically, 60% of these deaths are preventable.¹ Disparate maternal outcomes are a result of complex and multifaceted factors that require thoughtful and effective countermeasures. Training alone won't solve this crisis, but it can provide actionable tools, awareness, education, and enriched dialogue surrounding Black maternal health as we work together toward solutions to help reduce disparities in the communities we serve.

The training will include state specific data; learning outcomes will highlight:

- Overview of implicit bias and personal assessment.
- Understand and be able to identify implicit bias, the cognitive basis that informs bias, and its impact on the maternity care setting.
- Historical overview of structural racism in the U.S.
- Application strategies to mitigate racial bias in maternity care, such as the CARES Framework[™] and the practice of cultural humility.
- Strategies to build a culture of equity within an organization.

Providers will have the option to select from a virtual, instructor-led training, facilitated by March of Dimes[®], or self-paced e-learning. The virtual, live instructor-led training will be hosted on **October 12, 2022**. We encourage providers interested in the live training to register early because training seats are limited and first come-first serve. Awareness to Action: Dismantling Bias in Maternal and Infant Healthcare™ provides authentic, compelling content for health care providers caring for women before, during and after pregnancy. We offer implicit bias training to increase awareness and stimulate action to address implicit bias in maternity care settings.

Training alone won't lead to immediate improvements in racial and ethnic disparities, but it can provide health care providers with important insights to recognize and remedy implicit bias. These actions can result in improved patient-provider communication, overall patient experience and quality of care and a culture shift across committed organizations towards the broader goal of achieving equity for all moms and babies.



LEARNING OBJECTIVES

(1) Understand and be able to identify implicit bias, the cognitive basis that informs bias, and its impact on maternity care settings.

(2) Explain how structural racism has played a key role in shaping care settings within the U.S. and contributes to implicit biases in patient/provider encounters.

(3) Recognize one's potential for implicit bias and apply strategies, such as the CARES Framework™ and practice cultural humility, to effectively mitigate their own implicit biases.

(4) Recognize and establish a culture of equity as an organizational commitment through action planning to elevate the quality of maternity care.
